RESPECTIVE FUNCTIONS OF THE BOARD OF GOVERNORS AND PRINCIPAL IN RELATION TO ADMISSIONS

The admissions criteria will be applied by the Principal and appeals will be dealt with by the Board of Governors.

When considering which children should be selected for admission, the Board of Governors will only take into account information which is detailed on the application or provided directly to the school. Parents/Guardians should therefore ensure that all information pertaining to their child and relevant to the school's admissions criteria is stated on the application or provided directly to the first preference school. Examples of such information include whether the child has brothers/sisters attending the school, or is the eldest child in the family.

ADMISSIONS CRITERIA

During the admissions procedure when applying the criteria punctual applications will be considered before late applications are considered. The application procedure opens on 9 January 2024 at 12noon (GMT) and an application submitted by the closing date of 26 January 2024 at 12noon (GMT) will be treated as a punctual application. An application received after 12noon (GMT) on 26 January 2024 and up to 4 pm on 31 January 2024 will be treated as a late application, this is also the last date and time for processing a change of preference in exceptional circumstances. After 4 pm on 31 January 2024 no applications will be processed until after the close of procedure on 25 April 2024.

Admissions criteria to be used in the event of the school being oversubscribed. The criteria are listed in order of priority.

In the event of the school being oversubscribed the Board of Governors will apply the criteria.

Priority will be given to children who will have attained compulsory school age at the time of their proposed admission, including those children whose parents deferred their admission to primary school in September 2023 as defined by the new School Age (NI) Act (both groups to be treated equally).

Priority will be given to children resident in Northern Ireland at the time of their proposed admission to the school before those who are not so resident.

Admissions criteria are listed in the order of priority.

1. Children who, at the date of their application, have a child of the family currently enrolled at the school.
2. Children who have attended Mossgrove Nursery Unit.
3. Children who, at the date of their application, are the eldest child of the family to be eligible to apply for admission to the school. (Please see Duty to Verify)
4. Children for whom Mossgrove is the nearest school.
5. Final selection will be on the basis of children whose home address is nearest to Mossgrove Primary School as decided by a straight line digital measurement using 'Spatial NI' digital measurement tool.

Admissions criteria for entry September 2024

In the event of over subscription in the last sub-criteria which can be applied then selection for all places remaining in this category will be on the basis of the initial letter of the surname as per the birth certificate in the order set out below:-

D O' I A O T U X Y E L Q G P N Mac S V Mc K R J B W F Z C M H

The order was determined by a randomised selection of letters. In the event of surnames beginning with the same letter the subsequent letters of the surname will be used in alphabetical order. In the event of two identical surnames the alphabetical order of the initials of the forenames will be used as per the birth certificate.

DUTY TO VERIFY

The Board of Governors reserves the right to require such supplementary evidence as it may determine necessary to support or verify any information on the application. The provision of false or incorrect information or the failure to provide information within the deadlines set by the school can result in the inability of the school to offer a place/the withdrawal of a place. Only if oversubscribed, the school will make contact about verification documents in relation to the 'eldest child'. If requested by the school, parents can provide one of the following documents to prove eldest or only child; a letter from a member of the clergy; a public servant such as a health visitor or educational professional to include a pre-school Nursery teacher.

WAITING LIST POLICY

ADMISSION TO P2 – P7

Pupils will be admitted to P2-P7 in accordance with the preference expressed by a parent if the school's enrolment number has not been reached, unless to do so would prejudice the efficient use of resources. If oversubscribed the above criteria will also be used for admission of children from P2-P7.
